Capital Improvement Program Adoption and Highlights

The City's Capital Improvement Program (CIP), a five-year plan to address future infrastructure needs will be considered by the City Council on June 28. The plan, covering the fiscal years from 2022-23 through 2026-27, includes strategic plan projects. Key projects that will begin or continue in fiscal year 2022/23 include:

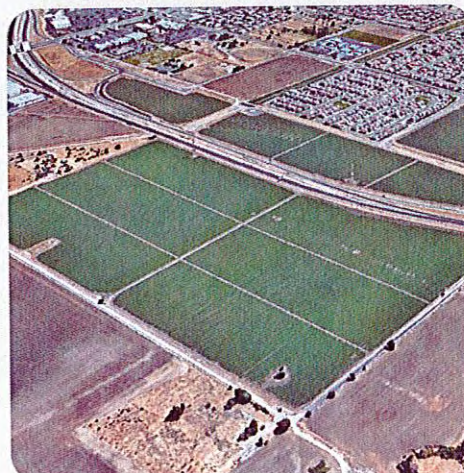
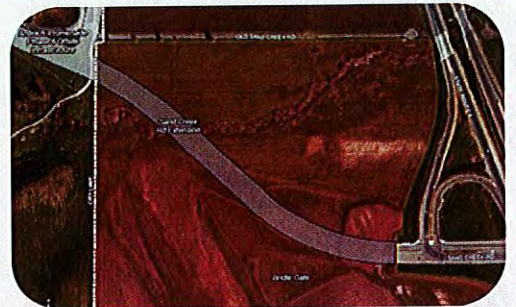


Sand Creek Sports Complex

This Strategic Plan project consists of design and construction of a sports complex on approximately 35 acres at Sand Creek Road and Fairview Ave. The complex will include up to six full-size multi-use sports fields, parking lot, restrooms, and other amenities.

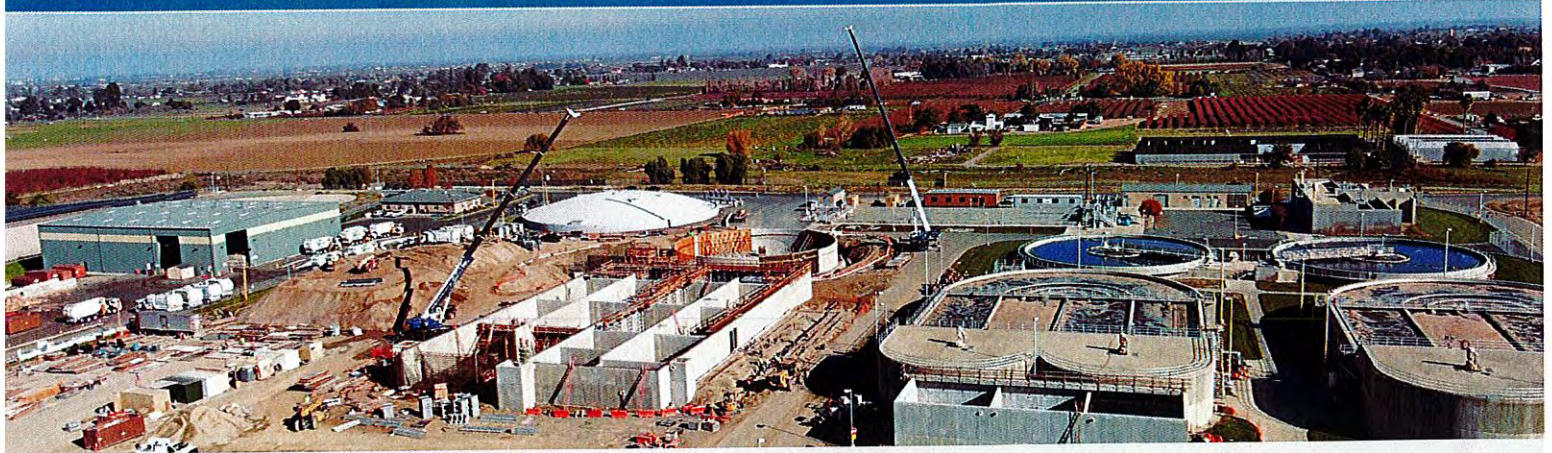
Sand Creek Road Extension

This Strategic Plan project will construct an extension of Sand Creek Road from the existing State Route 4 on/off ramp to Heidorn Ranch Road.



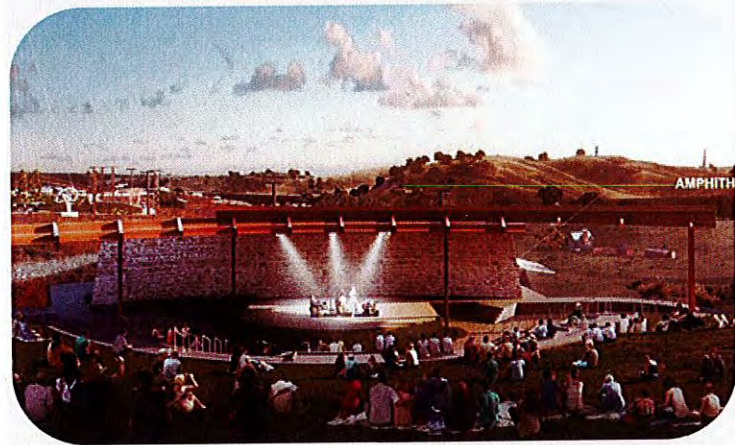
Innovation Center @ Brentwood Infrastructure

This Strategic Plan project will construct infrastructure improvements within the Innovation Center @ Brentwood, a 373-acre site located in the northwest corner of Brentwood. The center is expected to facilitate job creation and mixed-use development.



Wastewater Treatment Plant Expansion - Phase II

This project expands the existing treatment facility to ensure service capacity for the City's final buildout population. The expansion will also keep the system in compliance with increasingly stringent water discharge requirements.



Vineyards at Marsh Creek - Event Center/Amphitheater

This Strategic Plan project will include construction of an outdoor amphitheater and event center at the Vineyards at Marsh Creek development. Environmental studies will occur during the next year or so, with construction expected to start in 2024.

City Parking Garage Security and Safety Enhancements

This Strategic Plan project will install vehicle and pedestrian gate access points and provide security and safety enhancements to the City Hall parking garage.

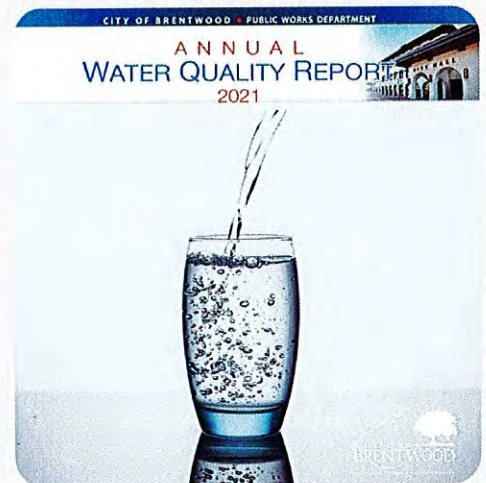

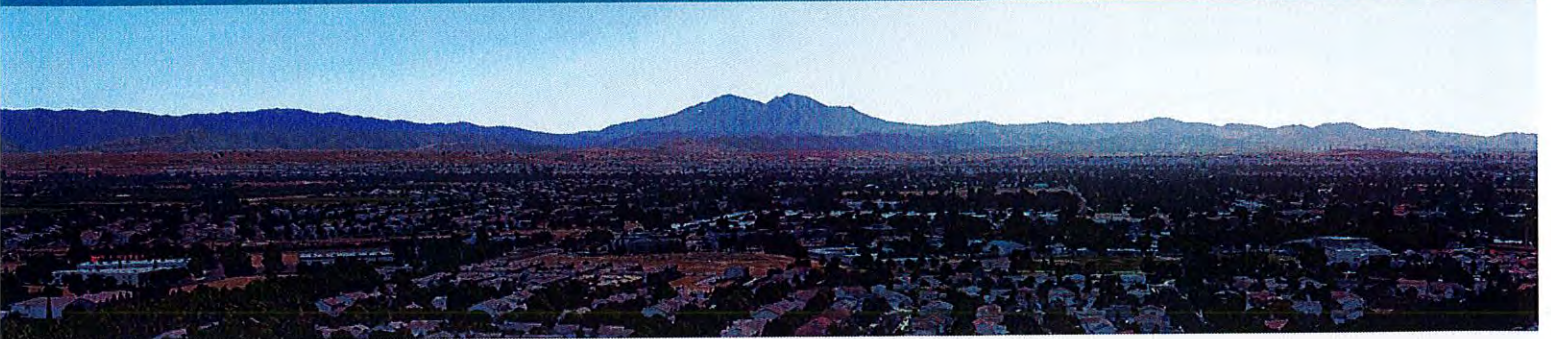
Proclamations

Land Use & Housing Bills

Each year the State Legislature passes legislation that impacts local land-use controls and decisions. Over the next couple of months, this newsletter will highlight recently adopted legislation. This month's highlight:

Housing Element Timing (AB 215) makes changes to Housing Element deadlines.

Specifically, AB 215 provides that the first draft of a housing element must be made available for public review and comment for at least 30 days. If any public comments are received, the local government must take at least 10 business days after the 30-day public comment period to consider and incorporate the comments. This must be done before submitting the draft housing element to CA Department of Community Development (HCD) for review. Otherwise HCD will not review the draft. Subsequent drafts must be posted electronically and those interested must be provided notice at least 7 days before submitting to HCD. Additionally, AB 215 extends the time that HCD has to review the first draft of the housing element to 90 days and reiterates that it has 60 days to review any subsequent drafts.

AB 215 also authorizes HCD to contract with an independent attorney to sue jurisdictions over housing law violations where the Attorney General has declined to bring suit or represent HCD. Lastly, it extends the statute of limitations to three years for actions brought by the Attorney General or HCD or pursuant to a notice of violation issued by HCD regarding housing laws.

SB 9: Allows Duplexes and Urban Lot Splits in Single Family Zones

Two-Unit Developments and Urban Lots Splits are permitted in accordance with the adoption of an urgency ordinance by the Brentwood City Council. These types of projects are allowed under California Senate Bill (SB) 9, which was signed into law by Governor Newsom and took effect on January 1, 2022. SB 9 allows duplexes (two-unit housing) and urban lot splits (the creation of two new lots) in areas of the City that are generally zoned to allow only one unit per parcel (traditional single-family zoning). As long as these projects are consistent with objective zoning, subdivision, and design standards, these projects are exempt from discretionary review and must be administratively approved. Senior Health & Resource Fair

The Brentwood Senior Activity Center hosted the Senior & Resource Fair on May 26 for seniors, family members, and caregivers. 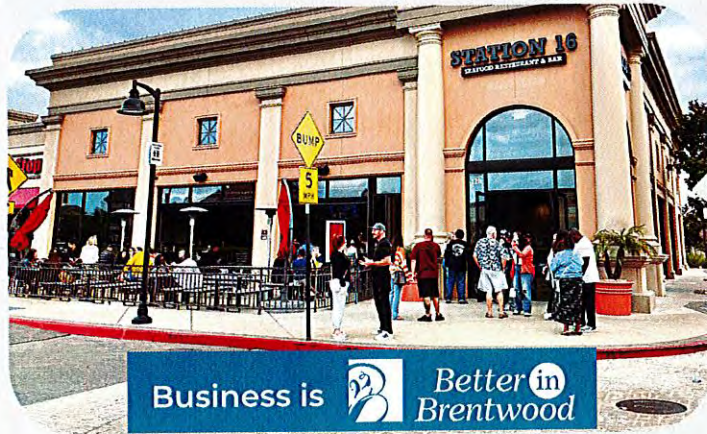
Join Us for the Brentwood Classic 4th of July Parade

Any pros/cons you have working for the City of Brentwood?

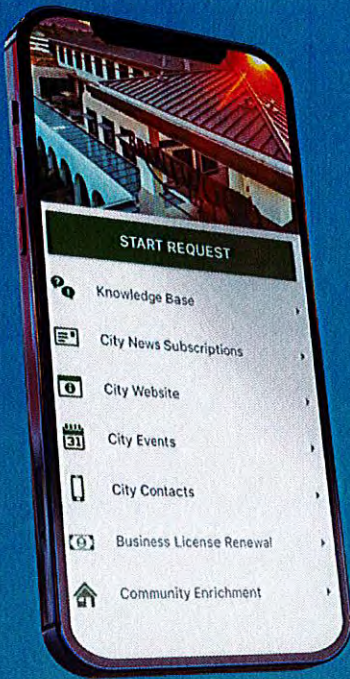
This is just a great group of people to work with. They really were so welcoming and they are like a family. I really do feel privileged to work here and I won the job lottery.

Did you know that overgrown street trees can cause delays for fire & medical personnel in the case of emergencies? Fire trucks require a

minimum vertical clearance of 13'6". Also, low hanging trees impact garbage collection and street sweeping accessibility. Taking a few moments to ensure your street trees meet city standards of 10' of clearance over the sidewalk and 15' of clearance over the street is not only important, but it may also save a life! 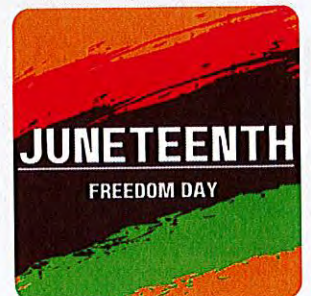

Last year, Juneteenth officially became a federal holiday commemorating the emancipation of enslaved African-Americans. In observance of Juneteenth, City offices will be closed on Monday, June 20.



Water Conservation

To help mitigate the impact of drought on the State, the Governor signed [Executive Order N-7-22](#), asking water agencies to implement actions consistent with Stage 2 of their Water Shortage Contingency Plans. This order calls on all Californians to limit summertime water use and to use water more efficiently indoors and out.

Stage 2 of Brentwood's plan asks residents and businesses to voluntarily reduce potable water use by 20 percent. Residents can find their current water use by visiting [Utility Billing Online](#) or reviewing their billing statement.

The City recognizes that Brentwood residents have already reduced average household water use by increasing their conservation actions during the last drought. Thank you for doing your part once again. Your continued efforts will help ensure a reliable resource for the future of all Californians.



Here are Ways to Reduce Water Usage by 20 Percent



- **Biggest Savings! Reduce Your Sprinkler by One Watering Day**

Doing so can save up to 400 gallons per week.

- **Read Your Meter**

Tracking your meter will help detect leaks. Fixing one leaky toilet can save up to 40 gallons per day. You can learn how to read your water meter and check for leaks at the [City's website](#).

- **Sweep Don't Spray**

Hosing down your driveway or patio is prohibited and you could save up to 10 gallons per minute by using a broom.

- **Mulch Around Plants**

A layer of mulch around trees and other plants in your garden saves you up to 80 gallons per day. Get discount [coupons for mulch here](#).

- **Water Early or Late**

Outdoor watering between 8 am and 7 pm is prohibited. Save up to 80 gallons per week by watering in the early morning or evening when temperatures are cooler.

- **Reduce Time in Shower**

Use a timer and shower for just 5 minutes and reduce up to 2.5 gallons per minute.

- **Choose Native or Drought Tolerant Plants from our [Drought Tolerant Plant List](#).**
