Stay Connected with the City of Brentwood



On May 17, 2023, Mayor Joel Bryant presented the State of the City address in person, delivering key insights about Brentwood's 75th anniversary and our rich history to an attentive audience. The Mayor elaborated on the City's focus on economic development while balancing and preserving our agricultural roots.

In the <u>Mayor's presentation</u>, several significant capital projects were high-

lighted. Notably, the construction of the Sand Creek Road extension has been delayed on account of a golden eagle nest and construction is expected to resume after August. Additionally, important upcoming meetings include a public hearing on proposed increases for water, wastewater, and solid waste rates on June 13; discussions regarding funding phases for the Sand Creek Sports Complex on the same date; and a Planning Commission public hearing on Costco on June 20. The City Council will consider the final Capital Improvement Projects on June 13 and Mid-Year Operations budget on June 27. We encourage all residents to participate in these meetings and stay informed.

Major City events were also highlighted in the Mayor's presentation, specifically an expanded July 4th celebration. This year's national holiday will feature additional 75th anniversary festivities such as the annual parade, the return of Carnique, a Ghostlight Theatre Ensemble original production, games, prizes, food, swimming, Concert in the Park, and a drone show. It'll be a full day downtown filled with festivities for all ages.

The Mayor's final remarks touched on two valuable resources for residents. First, residents can track the status of our Strategic Plan through a new online dashboard at <u>https://brentwood.info/strategic-goals</u>. The Strategic Plan encompasses approximately 40 initiatives that impact all aspects of our residents lives. Second, we have also added a capital project dashboard at <u>https://brentwood.info/CIP_Projects</u> where residents can track the progress of major projects planned for Brentwood.

Sand Creek Sports Complex Update

The City Council will review the Sand Creek Sports Complex on June 13, determining the course of action for the project's initial phase. The Parks and Recreation Commission previously approved the overall conceptual design on April 27, 2023. However, cost estimates exceeded the approved budget, prompting the Commission to recommend phased implementation based on available funding. With the City Council's approval of additional funding, a total of \$19.2 million has been allocated for the project. Specific details for the first phase are recommended to include:

- Three (3) 70 x 110 yard sports fields with artificial turf (lined for both soccer and lacrosse)
- Sports field lighting
- Parking lot (initially 270 spaces on asphalt)
- Restroom/storage/concession/staff building
- Various smaller park amenities including bike racks, park signage, drinking fountains, trash and recycling receptacles
- Infrastructure for entire Phase 1 with stub outs for future project phase(s)

It is also recommended that the first phase be bid with several bid alternates, so that additional parts of the project can be constructed, should the existing funding allow. Bid alternates with this phase could include:

- 1. Picnic areas, warm up areas, and planting
- 2. Multi-use hard court and picnic areas
- 3. Maintenance area
- 4. Completion of second half of the parking lot.

On June 13, staff will request confirmation of the conceptual plan and direction from the City Council for a list of elements to include in the first phase. The city will then complete designs and environmental reviews through 2023.
