## 2019 Water Quality Reports Available

Each year, EID provides its customers with an annual water quality report (sometimes referred to as a consumer confidence report) to let you know how our water quality stacks up against established federal and state drinking water standards.

We encourage you to review this report as it provides details about the source and quality of the drinking water delivered to your community in 2019.

### WHERE YOUR WATER COMES FROM

EID maintains three water systems and has rights to approximately 75,000 acre-feet of water from various sources in the Sierra Nevada foothills (an acre-foot equals one acre of land covered by a foot of water; there are 325,851 gallons in an acre-foot). Jenkinson Lake, at the center of Sly Park Recreation Area in Pollock Pines, provides nearly one half of our main system's water supply.

The main water system runs from El Dorado Hills to Pollock Pines and encompasses the majority of EID's service area, providing water to nearly 128,000 people. The Outingdale system provides water from the Middle Fork of the Cosumnes River to approximately 540 people in the small community of Outingdale, about 15 miles southeast of Placerville. The Strawberry system provides water from the upper South Fork American River to approximately 400 people in the community of Strawberry located about 40 miles east of Placerville along Highway 50.

## A Message From SLY PARK RECREATION AREA

EID is following the guidance and directives of the El Dorado County Public Health Officer, California Department of Public Health State Public Health Officer, Governor's Stay at Home Order, and the Centers for Disease Control and Prevention (CDC) guidelines regarding all of its operations, including the recreational opportunities associated with Sly Park Recreation Area (SPRA).

EID will re-open the SPRA to the general public based upon the recommendations and guidance of local and state health officials, and consistent with State Park ([https://www.parks.ca.gov/?page\\_id=30350](https://www.parks.ca.gov/?page_id=30350)) and U.S. Forest Service practices for developed recreation areas.

When SPRA reopens, there will most likely be restrictions on the number of guests and types of activities and locations that are accessible. These restrictions will be eased as conditions improve and guidance and directives from local, state, and federal health officials indicate it is appropriate to do so.

It is important that EID works in close coordination with our regional partners such as State Parks and the U.S. Forest Service to balance recreation opportunities across our region and ensure activities are conducted in a safe manner. To move forward or to stagnate? That is the question.

After two months of sheltering in place it is interesting to see what we've done with our time.

Not all of us were binge watching "Tiger King." In fact, the majority of us were quite busy.

Last month I was supposed to attend a 200-person seminar in Texas on how to do webinars. Turns out we did our three days of learning — via webinar. The meta-learning was fantastic, to say the least.

I learned topics trending in 2019 had leaped three years ahead of expectation due to the shelter-in-place orders around the country. Among these are the use of webinars and online learning.

While no one is saying that face-to-face business meeting or the value of attending a seminar or college course in a classroom is going away ... our future is changed. It is true that concerts and sporting events in arenas will return but timelines are uncertain.

In the meantime folks are learning new skills online — for professional and personal interests. Nearly all center on the conservation of time so more time is spent with — and for — loved ones.

In the midst of the crisis artists and other creative souls chose to pivot.

One artist I know of back east saw sales of his prints take a nosedive. Figuring he had nothing to lose and seeing the sudden popularity of jigsaw puzzles, he

decided to sell some of his art as jigsaw puzzles.

He sold out the first day online.

Some of us decided that now is the time to do some creative home projects. There are demolitions everywhere, as hardware stores can attest.

Some of us planted gardens. Others are baking bread for the first time.

And some of us tackled creative projects we put off for years.

## Circle of Life

The most delightful project I've encountered this month is by El Dorado Hills resident Sandy Hilton. The retired Folsom Community and Cultural Services manager created a table that honors the past and gives hope for the future.

"Sixty-nine years ago my parents planted two California Sycamore trees in the backyard of their Burbank home. Over the years those trees grew into 100-foot tall beauties and watched over the events that unfolded in our lives," she posted on Facebook. "Sadly, they grew so big they began to uproot my mom's neighbor's garage. In 2015 we had to cut the trees down. My mom was devastated."

"I kept a large rough cut section of the trunk and vowed to create a table from it. It sat in my garage next to where I park for the last four years, constantly reminding me it needed to be completed. I just couldn't gather up the energy to do it — until the stay-at-home orders hit. Now, with lots of time on my hands, I got inspired."

"As I began sanding the top, the rings of life began to reveal themselves. I could see the ring from the year my brother was born, followed by me two years later. There is the ring of the year Bruce and I were married, followed by the birth of Jen and Brett and that of our first grandson. My parents' 50th anniversary is there. There is a ring that marks the year my dad passed away."

"My mom passed away exactly a year after the trees were removed but the sadness in losing them gave way to the rebirth of her garden due to the now abundant sunshine."

"I completed the sanding and finishing and Bruce installed the iron legs. The Circle of Life table and all of its rings of life now sits in our living room. I also saved a limb and my son took two limbs and we made stump tables from them. I think my mom would love how these pieces of the tree were saved."

When I asked Sandy if I could share this story with all of you, she graciously gave her consent, adding, "If it gives a little boost of inspiration, then the trees will keep sharing their life to others. Maybe this 'great pause' will give us something positive like the importance of family and the preservation of memories."

It was a good reminder to me that when the daily news makes me discouraged, true meaning and happiness may be no further away than that family project in my own backyard or in a conversation with my neighbor over the fence.

As the county and the country reopen, let's keep the positive things going.

# Water Quality / Consumer Confidence Report

## Water Source and Testing Information

### About the Water Quality Report

The Water Quality Report is an annual summary of the results of ongoing tests for contaminants in drinking water. The report is designed to inform you of the quality of your drinking water. Each year, the State Water Resources Control Board (State Water Board) and U.S. Environmental Protection Agency (EPA) require EID to compile and distribute a report to all of our water customers. The report includes a comparison of the District's water quality to state and federal standards.

### Where Your Water Comes From

EID maintains three water systems. The **Main Water System** runs from El Dorado Hills to Pollock Pines and encompasses the majority of our customers with 41,089 service accounts. The **Outingdale Water System** provides water from the Middle Fork of the Cosumnes River to 189 service accounts in the small community of Outingdale, approximately 15 miles southeast of Placerville. The **Strawberry Water System** provides water from the upper South Fork American River to 190 service accounts in the community of Strawberry located approximately 40 miles east of Placerville along Highway 50.

EID has rights to approximately 75,000 acre-feet of water from various sources in the Sierra Nevada foothills. (An acre-foot equals one acre of land covered by a foot of water; there are 325,851 gallons in an acre-foot.) Jenkinson Lake, at the center of Sly Park Recreation Area, provides nearly one half of our Main System's water supply. Forebay Reservoir in Pollock Pines delivers water under a pre-1914 water right from the high-alpine streams and lakes that are part of our Project 184 hydropower system. We have a water contract with the Bureau of Reclamation at Folsom Lake, which Reclamation operates as part of the state's Central Valley Water Project. And we hold ditch water rights (Weber, Slab, and Hangtown creeks), water rights at Weber Reservoir, and a water right under Permit 21112 for Project 184 water—all of which is delivered from Folsom Lake.

### Information About Potential Sources of Pollution

The State Water Board requires water providers to conduct a source water assessment to help protect the quality of water supplies. The assessment describes where a water system's drinking water comes from, the types of polluting activities that may threaten the quality of the source water, and an evaluation of the water's vulnerability to the threats.



Updated assessments of EID's drinking water sources were completed in 2018. Our source water is considered most vulnerable to recreation, residential sewer, septic system, and urban runoff activities, which are associated with constituents detected in the water supply. Our source water is also considered most vulnerable to illegal activities, dumping, fertilizer, pesticide and herbicide application, forest activities, and wildfires, although constituents associated with these activities were not detected. ## Testing the Water

To help ensure that safe water is delivered to our customers, EID's water quality monitoring program includes taking samples of raw and treated water throughout the year from many locations in the District's service area. Analyses cover more than 100 different constituents. Analysis of the water is performed at state-certified commercial labs. The state of California allows us to monitor for some contaminants less than once a year because the concentrations of the contaminants do not change frequently. Some of our data, although representative, may be more than a year old. When available, the data reported reflects the treated water supply.

## A Note For Sensitive Populations

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. USEPA/Centers for Disease Control guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants are available from the Safe Drinking Water Hotline at 1-800-426-4791.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. EID is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. ## Lead in Schools

In January 2017, the State Water Resources Control Board, Division of Drinking Water amended public water system domestic water supply permits to require for lead monitoring and lead sample result interpretation at K-12 schools served by the water system that have submitted a written request for lead sampling related assistance. Seventeen schools requested testing related to this requirement. In October 2017, the Governor approved AB 746

amending the Health and Safety Code (HSC) §116277. The new law requires Community Water Systems serving public school sites of a local education agency with buildings constructed before January 1, 2010 to test for lead in the potable water system of the school site before July 1, 2019. Thirty-six schools out of 36 schools served by the Main Water System have been sampled to date. ## **Triennial Public Health Goal Report for the Drinking Water in the Main Water System**

### **Your Drinking Water—What You Should Know**

The sources of drinking water-both tap and bottled-include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material and can pick up substances resulting from the presence of animals or from human activity.

The following contaminants may be present in source water before it is treated.

**Microbial contaminants** such as viruses and bacteria from sewage treatment plants, septic systems, livestock operations, and wildlife.

**Inorganic contaminants** such as salts and metals that occur naturally or stem from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, and farming.

**Pesticides and herbicides** from sources such as agriculture, urban stormwater runoff, and residential uses.

**Organic chemical contaminants** such as synthetic and volatile organic chemicals that are byproducts of industrial processes and petroleum production or that come from gas stations, urban stormwater runoff, agricultural applications, and septic systems.

**Radioactive contaminants** that occur naturally or are the result of oil and gas production and mining.

To ensure that tap water is safe to drink, the U.S. Environmental Protection Agency and the State Water Resources Control Board prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. State Board regulations also establish limits for contaminants in bottled water that must provide the same protection for public health.

NOTE: Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk.
