

Customers signed up for electronic bill-pay (i.e. receive electronic billing statements) were emailed notification that the CCR is available. The electronic notification included a direct URL link to the CCR embedded in the message text and a PDF attachment of the CCR. Email delivery was conducted on May 6, 2019.

Customers who receive a paper billing statement were mailed a full-page insert with the water bill mailed June 7, 2019. The notification provided a direct URL to the CCR, language on how to perform a web search that will result in finding available CCRs and notice that a hard-copy of the CCR is available upon request.
