## Sources of Drinking Water and Contaminants that May Be Present in Source Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, that can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, that may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, that are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, agricultural application, and septic systems.
- Radioactive contaminants, that can be naturally-occurring or be the result of oil and gas production and mining activities.

## Regulation of Drinking Water and Bottled Water Quality

In order to ensure that tap water is safe to drink, the U.S. EPA and the State Board prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. The U.S. Food and Drug Administration regulations and California law also establish limits for contaminants in bottled water that provide the same protection for public health.

### Drinking Water Contaminants Detected

Tables 1, 2, 3, 4, 5, 6, and 8 list all of the drinking water contaminants that were detected during the most recent sampling for the constituent. ### **USG Public Water System CA1300517 has not completed its initial Lead Service Line Inventory**

The Safe Drinking Water Act's (SDWA's) Lead and Copper Rule Revision (LCRR) required all water systems to develop a service line inventory that identifies the material and location of each service line connected to the public water distribution system (40 CFR § 141.84(a)). The LCRR also required all public water systems to develop an initial inventory and submit it to the DDW by October 16, 2024 (40 CFR §§ 141.84(a)(1) and 141.90(e)(1)). Our water system failed to complete its initial Lead Service Line Inventory as required and, therefore, was in violation of the regulations. Even though this failure was not an emergency, as our customers, you have a right to know what happened, and what we are doing to correct this situation.

#### **What should I do?**

- There is nothing you need to do at this time.
- While the ground water supplied to the facility is used primarily for production purposes and not drinking water, employees still use this water for sanitary purposes such as flushing toilets and hand washing.

#### **What happened? What is being done.**

US Gypsum is a wallboard facility that was built in 1945. It was later required to obtain a public water system permit to operate its wells for the purposes of wallboard production and employee needs. US Gypsum's water system was purpose built to support a wallboard facility. No "as built" drawings were filed/recorded as would have been the case with a public water system that services rate paying customers. In summary, there are no "as built" drawings or fixture inventories available to complete an initial Lead Line Survey.

US Gypsum is currently in discussions with CDM Smith to complete the necessary work to comply with The Safe Drinking Water Act's (SDWA's) Lead and Copper Rule Revision (LCRR)


