## Cal Poly Pomona Releases Water Quality Report for 2023

<u>Facilities Planning & Management</u> has released its <u>2023 Water Quality Report</u>. The in-depth report contains important information about the quality of the campus drinking water and the university's efforts to continue to provide the highest quality water.

In 2023, Cal Poly Pomona's drinking water met or exceeded all drinking water health standards of the U.S. Environmental Protection Agency and the State of California. The report covers testing of campus water between Jan. 1, 2023, and Dec. 31, 2023.

In order to ensure that water is safe to drink, the U.S. Environmental Protection Agency (EPA) and the State Water Resources Control Board (State Water Board) prescribe regulations that limit the number of certain contaminants in water provided by public water systems.

For 2023, the drinking water delivered to the campus community met or exceeded the standards established by these federal and state agencies. This annual report fully complies with the regulations of the 1996 Safe Drinking Water Act.

CPP uses both ground and surface water supplies to produce drinking water. Most of the drinking water that is produced comes from the domestic groundwater Well 1 that is located on university property and permitted by the State Water Board. This domestic water well is tapped into the Spadra groundwater basin and water extracted from this well is treated by a process known as reverse osmosis. The treated water may also be blended with water purchased from the Metropolitan Water District of Southern California (MWD).

#### **CPP Receives Record Number of First-Year Student Applications**

The university received a record 51,022 applications from first-time freshmen for fall 2024 — a more than 10 percent increase over last year. Combining both aspiring first-year and transfer student applications brings the total to over 63,000 students hoping to join the Bronco community. "The big story here is the high demand for our amazing, diverse programs; hands-on learning opportunities; and the university's industry connections," says Senior Associate Vice President for Enrollment Management and Services Jessica Wagoner. "On top of that, we
