

The in-depth report covers testing of campus water between Jan. 1, 2024, and Dec. 31, 2024 and contains important information about the quality of the drinking water supply and the university's efforts to continue to provide the highest quality water. In 2024, Cal Poly Pomona's drinking water met or exceeded all drinking water health standards of the U.S. Environmental Protection Agency and the State of California. The drinking water delivered to the campus community in 2024 met or exceeded the standards established by these federal and state agencies. This annual report fully complies with the regulations of the 1996 Safe Drinking Water Act.




# IN THE NEWS

The Department of Homeland Security said Velez was taken into custody when she "forcefully obstructed an ICE officer," a claim her family denies.
