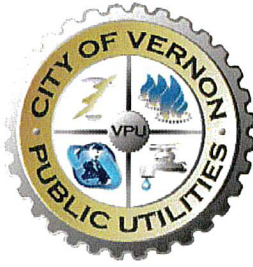

The City of Vernon sent a Notice of Electronic Delivery of the 2020 Annual Water Quality Report through a mass mail-out to customers. The subject Notice provided a prominently displayed Uniform Resource Locator (URL) with a direct link to the CCR and a notice

explaining the nature of the link. The subject Notice also provided information on who to contact in the event a hard copy is desired. This information was provided in both English and Spanish. Additionally, availability of the CCR is announced on the City website's homepage with a direct link on the banner. The Notice was posted on the City Hall bulletin board—4305 Santa Fe Avenue. Hard copies of the CCR are available over the counter in City Hall at the Customer Service lobby and Public Works counter. Announcement of the availability of the CCR was also posted on the City's social media accounts (i.e., Facebook, Instagram, Twitter), including a URL with a direct link to the CCR.

**NOTICE OF ELECTRONIC DELIVERY OF THE 2020 ANNUAL WATER QUALITY REPORT
FOR CITY OF VERNON CUSTOMERS**

This Notice contains instructions on how to obtain important information about your drinking water.

The Safe Drinking Water Act (SDWA) requires that the City of Vernon (City) provide you with an Annual Water Quality Report. The purpose of the Annual Water Quality Report is to raise customers' awareness of the quality of their drinking water, where their drinking water comes from, what it takes to deliver water to their homes or businesses, and the importance of protecting drinking water resources.

In recent years, the City has mailed a printed copy of the Annual Water Quality Report to comply with the SDWA. On February 13, 2013, the California Department of Public Health expanded its interpretation of the SDWA to allow for electronic delivery of the Annual Water Quality Report. The electronic delivery method allows the City to reduce the use of paper and minimize printing and mailing costs.

Este aviso contiene instrucciones sobre cómo obtener información importante sobre su agua potable.

La Ley de Agua Potable Segura (SDWA, por sus siglas en inglés) requiere que la Ciudad de Vernon ("Ciudad") le proporcione un Informe Anual de Calidad del Agua. El propósito del Informe Anual de Calidad del Agua es sensibilizar a los clientes sobre la calidad de su agua potable, de dónde proviene su agua potable, lo que se necesita para suministrar agua a sus hogares o negocios y la importancia de proteger los recursos de agua potable.

En los últimos años, la Ciudad ha enviado una copia impresa del Informe Anual de Calidad del Agua para cumplir con la SDWA. El 13 de febrero de 2013, el Departamento de Salud Pública de California amplió su interpretación de la Ley de Agua Potable Segura para permitir la entrega electrónica del Informe Anual de Calidad del Agua. El método de entrega electrónica permite a la Ciudad reducir el consumo de papel y minimizar los costos de impresión y envío.
