LVMWD utilized multiple outlets and platforms to notify the entirety of our service area that the 2018 Consumer Confidence Report was available. The primary notification method was a direct mail postcard distributed to all postal zip codes where LVMWD receiving LVMWD service. On this postcard there were instructions in both English and Spanish on how residents within our service area could request a paper copy of the CCR. The LVMWD Public Affairs staff collected the addresses of those who wished to receive a paper copy and then mailed them out. The ads that LVMWD placed in our local papers also had instructions for customers to call if they wished to receive a paper copy of the 2018 CCR. Additionally, LVMWD staff has delivered the 2018 CCR to the libraries, city halls, community organizations and common places that we serve as well as having the CCR available at all community events that the District participates in.
