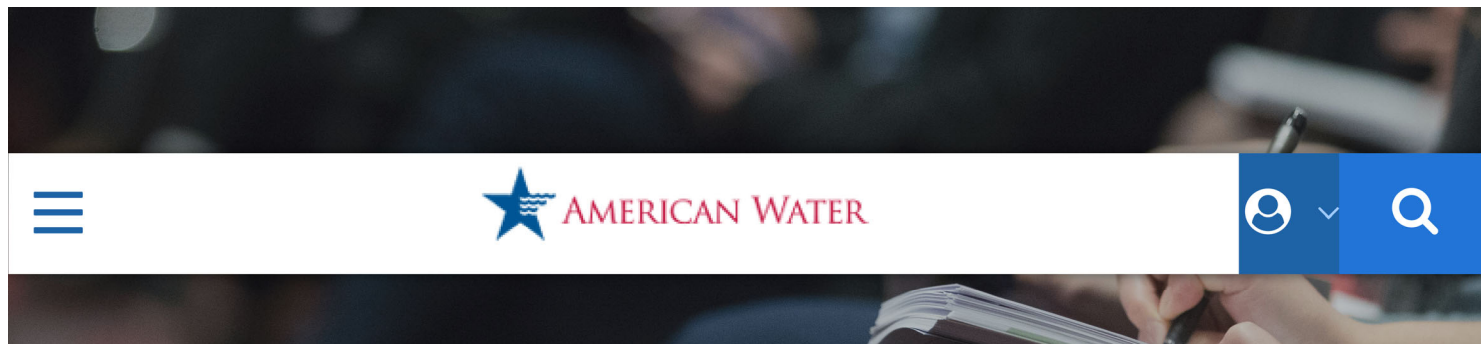

It will become past due if not paid within nineteen (19) days from the date of the mailing. If you believe there is an error on your

bill or have a question about your service, please call California American Water Company customer support at 1-888-237-1333. - California American Water has filed advice letter 1326 with the California Public Utilities Commission to rename its low-income water assistance program to the Customer Assistance Program (CAP). Previously, the program was called the Low-Income Ratepayer Assistance Program (LIRA). Through this filing California American Water reflects this name change on all applicable tariffs, forms, letters, and customer bills.
  - Through AL 1326 customers in Fruitridge Vista will begin paying the Customer Assistance Program (CAP) surcharge to fund the CAP program. The surcharge will appear on customer bills on or around 3/19/2021. A typical residential customer will see an increase of \$1.84 per month, a 4.58 percent increase.
