Sources of Drinking Water and Contaminants that May Be Present in Source Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, that can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, that may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, that are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, agricultural application, and septic systems.
- Radioactive contaminants, that can be naturally-occurring or be the result of oil and gas production and mining activities.

Regulation of Drinking Water and Bottled Water Quality

In order to ensure that tap water is safe to drink, the U.S. EPA and the State Board prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. The U.S. Food and Drug Administration regulations and California law also establish limits for contaminants in bottled water that provide the same protection for public health.

Drinking Water Contaminants Detected

We tested for 23 SOC's (Synthetic Organic Chemicals) in 2021. All items were reported below detectable levels. We also tested Well #1 for 11 Soc's in 2021. All items were reported below detectable levels. We tested Well #3 for 31 VOC's (Volatile Organic Chemicals) in 2020. All items were reported below detectable levels. We tested Well #1 for 27 VOC's in 2017. All items were reported below detectable levels. We tested for Chromium VI in 2015, the results were ND (non-

detect). We tested for Perchlorate in 2018, the results were ND. Total Dissolved Solids and Specific Conductance exceed the Secondary (aesthetic) drinking water standards.

Some people find the taste of high dissolved solids in water objectionable, yet similar high dissolved solids water is bottled and sold as mineral water. It is not economically feasible to lower the dissolved solids level at the central treatment plant. If you find the taste of high dissolved solids in water unpalatable, you may prefer low dissolved solids bottled water (natural, deionized, reverse osmosis, distilled, purified) or can install treatment devices, available from many water conditioning companies that reduce the dissolved solids of your tap water.
