In 2020, Padre Dam Municipal Water District's drinking water met or surpassed every public health requirement set by the State Water Resources Control Board Division of Drinking Water and the United States Environmental Protection Agency.

East County Advanced Water Purification Program Awarded \$388 Million Low-Interest Loan

The East County Advanced Water Purification Program received a \$388 million Water Infrastructure Finance and Innovation Act (WIFIA) loan from the U.S. Environmental Protection Agency to help finance the Program.

The low-interest loan will save ratepayers \$130 million and help create more than 2,500 jobs.

Scheduled to be complete in 2025, the East County AWP Program will



create a new, local, sustainable and drought-proof drinking water supply using state-of-the-art technology to purify East San Diego County's recycled water. The Program will generate up to 11.5 million gallons per day of new drinking water—approximately 30% of current drinking water demands for East San Diego County residents.

This is the first EPA WIFIA loan awarded to the Program, the largest to a project in East San Diego County and the second-largest in all of San Diego County. The WIFIA program accelerates investment in the nation's water infrastructure by providing long-term, low-cost supplemental loans for regionally and nationally significant projects.
