All but two VRMWC customers use e-mail for receiving their bi-monthly water invoices. Thus all but two VRMWC regular customers have access to e-mail notifications.

47 of 49 customers received an e-mail notification on March 17, 2020, that the 2019 CCR is available on the community website. A direct link to the document was included in the e-mail notification. In addition, an electronic file e-mail attachment of the 2019 CCR was included with the e-mail notification.

Paper copies of the CCR were mailed by USPS mail to the two customers that do not use e-mail.

Paper copies of the CCR were also hand delivered to the one part-time employee of Varian Ranch, and to the tenants of the apartment above the barn.
