ANNUAL CONSUMER CONFIDENCE REPORT TO CUSTOMERS

Dear Customer:

California Drinking Water Regulations require that every water system annually report to their customers on the quality of water served during the previous year. The attached Consumer Confidence Report is intended to help Port San Luis Harbor District (Port) customers become more informed on the quality of the Port's water and our compliance with the regulations. The drinking water delivered by the Port is purchased from the Lopez Water Supply Project, owned and operated by Zone 3 of the County of San Luis Obispo. The source is delivered through the Lopez water delivery system.

Information in this report was obtained from analyses performed between January 1, 2024 and December 31, 2024 from the Lopez Water Treatment Plant, the Polonio Pass Water Treatment Plant, or the Port's distribution system. Results may also include earlier monitoring data. Treated State water is blended with Lopez water in the County's distribution system originating at the Lopez Dam. In addition to routine testing performed by San Luis Obispo County (Lopez water) and the Central Coast Water Authority (State water), the Port also reports the results of monthly bacteriological testing samples taken from the Port's distribution system.

Water quality at various locations throughout the distribution system can vary from time to time. This is due to operational procedures, system limitations, chemical reactions, and climatic changes. However, all drinking water delivered by the Port meets all mandatory health-related standards established by the State of California Division of Drinking Water.
