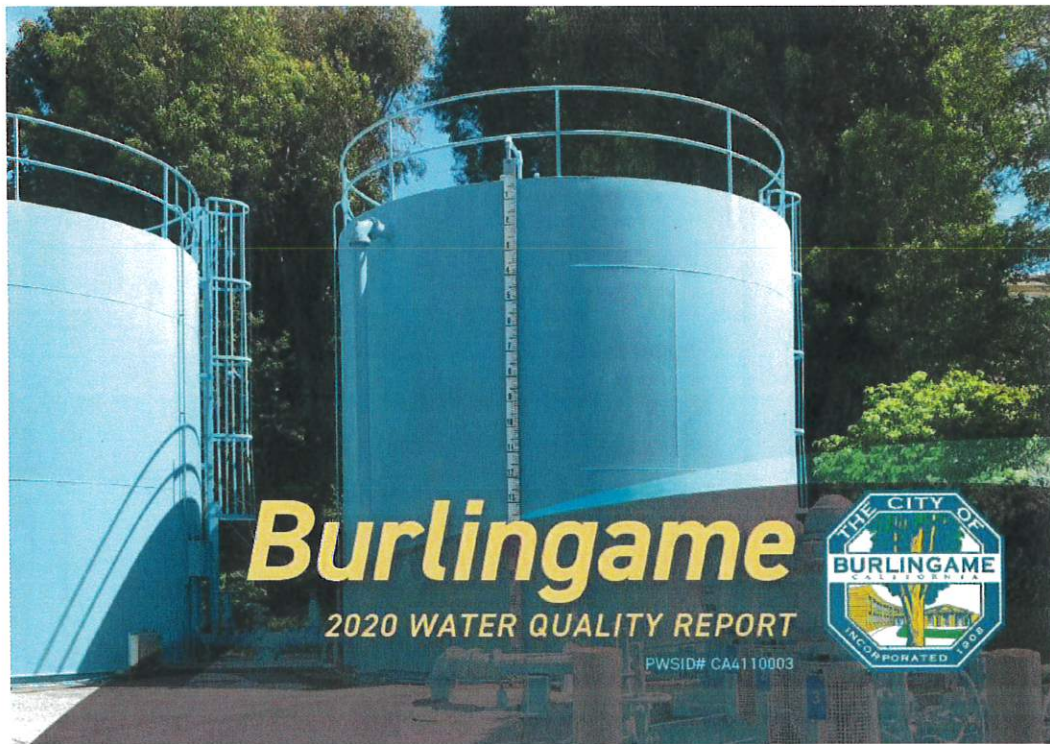

Old Bayshore Highway Corridor Improvements Survey #2 Open Through July 5

The City is conducting a feasibility study to look at potential roadway improvement designs for Old Bayshore Highway, from the northern city limits to the U.S. 101 northbound ramps. This study will look at improving the access, safety, operations, and aesthetics of Old Bayshore Highway for all modes of transportation (pedestrians, bicycles, vehicles, and transit).

The City has been working with various public and private stakeholders, including business owners, property owners, residents, and City Commissions, to present project context, opportunities, and constraints, as well as to solicit feedback that will determine the community's priorities for the corridor. **The second community survey is now underway.** The goal is to see how the community feedback has shaped the preliminary alternatives, as well as allow us to refine the design priorities!
