Name and General Location of Source(s): **Our drinking water wells are located near 1550 Burton Mesa Boulevard, where water is drawn from the Lompoc Uplands Aquifer.**

Drinking Water Source Assessment Information: **MHCS D conducted the drinking water source assessment of Well 5 in 2002 and Wells 6 and 7 in 2009. The wells were found to be most susceptible to possible contamination from utility station maintenance areas, drinking water treatment plants, high density housing, historic gas stations, wastewater treatment plants, lagoons/liquid wastes, parks, water supply wells, sewer collection systems, contractor or government agency equipment storage yards, and storm drain discharge points. The most recent Sanitary Survey was completed in 2024. About This Report

We test the drinking water quality for many constituents as required by state and federal regulations. This report shows the results of our monitoring for the period of January 1 to December 31, 2024, and may include earlier monitoring data.

Terms Used in This Report

Term	Definition
Level 1 Assessment	A Level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.
Level 2 Assessment	A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an <i>E. coli</i> MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.
Maximum Contaminant Level (MCL)	The highest level of a contaminant that is allowed in drinking water. Primary MCLs are set as close to the PHGs (or MCLGs) as is economically and technologically feasible. Secondary MCLs are set to protect the odor, taste, and appearance of drinking water.

Sources of Drinking Water and Contaminants that May Be Present in Source Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

Microbial contaminants, such as viruses and bacteria, that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

Inorganic contaminants, such as salts and metals, can be naturally occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

Pesticides and herbicides, that may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.

Organic chemical contaminants, including synthetic and volatile organic chemicals, that are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, agricultural application, and septic systems.

Radioactive contaminants, that can be naturally occurring or be the result of oil and gas production and mining activities.

Regulation of Drinking Water and Bottled Water Quality

In order to ensure that tap water is safe to drink, the U.S. EPA and the State Board prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. The U.S. Food and Drug Administration regulations and California law also establish limits for contaminants in bottled water that provide the same protection for public health.

Drinking Water Contaminants Detected

Tables 1, 2, 3, 4, and 5 list all the drinking water contaminants that were detected during the most recent sampling for the constituent. The presence of these contaminants in the water does not necessarily indicate that the water poses a health risk. The State Board allows us to monitor for certain contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of the data, though representative of the water quality, are more than one year old. Any violation of an AL, MCL, MRDL, or TT is asterisked. Additional information regarding the violation is provided later in this report.

WATER SOFTENERS VS. CHLORIDE



While it costs an estimated 20 cents to add a pound of salt to water, it costs five dollars to remove it.

Q: What is Chloride?

A: Chloride is one of two components of sodium chloride, also known as table salt or rock salt. When salt dissolves in water, it separates into sodium (Na⁺) ions and chloride (Cl⁻) ions.

Q: Where does chloride come from?

A: Small amounts of chloride come from soaps, detergents, and other cleaning products. A significant amount of chloride comes from self-regenerating water softeners.

Q: How does it get in our wastewater treatment plant?

A: From the water softener, chloride is flushed into the sewer where it goes to the wastewater treatment plant. Treatment plants are designed to remove solid particles, like grit and sand; and to naturally break down organic waste, such as food and human waste. Once chloride is dissolved in water, it cannot be removed by settling, degraded by a standard treatment process.

Q: Can treatment plants be modified to remove chloride?

A: The technology to remove chloride is available, but it is very costly. Households could remove up to 100 lbs. of salt a month by using a “no salt” water softener

Q: What are the alternatives to reduce chloride?

A:

- *Remove water softeners that use salt
- *Use “No Salt” water softener
- *Use reverse osmosis water softener

***Please note that the District adopted an Ordinance in 2013 that prohibits the use of self-generating water Softeners.**
