We test the drinking water quality for many constituents as required by state and federal regulations. This report shows the results of our monitoring for the period of January 1, 2023, to December 31, 2022, and may include earlier monitoring data.

#### Sources of Drinking Water and Contaminants that May Be Present in Source Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, that can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, that may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, that are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, agricultural application, and septic systems.
- Radioactive contaminants, that can be naturally-occurring or be the result of oil and gas production and mining activities.

#### Regulation of Drinking Water and Bottled Water Quality

In order to ensure that tap water is safe to drink, the U.S. EPA and the State Board prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. The U.S. Food and Drug Administration regulations and California law also establish limits for contaminants in bottled water that provide the same protection for public health.

## About Your Drinking Water Quality Drinking Water Contaminants Detected

Table 1 lists all of the drinking water contaminants that were detected during the most recent sampling for the constituent. The presence of these contaminants in the water does not necessarily indicate that the water poses a health risk. The State Board allows us to monitor for certain contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of the data, though representative of the water quality, are more than one year old. Any violation of an AL, MCL, or MRDL is asterisked.

#### **Additional General Information on Drinking Water**

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. # Summary Information for Violation of the Monitoring and Reporting Requirement Violation of a Monitoring Reporting Requirement

Our water system failed to monitor as required for drinking water standards during the past year.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. In June 2023, Notice of Violation No. 02\_17\_23N\_002, a raw water bacteriological sample at Well 01 was not collected, however the distribution system was negative for Total Coliform. During December 2023, we failed to collect repeat bacteriological samples following a Total Coliform positive result. Alma Latter-Day Saints Church water system has satisfactorily complied with the directives of Citation and Compliance Order No. 02\_17\_23J\_002 (enforcement action) issued December 21, 2023, and is hereby returned to compliance related to this enforcement action. The enforcement action was issued due to a failure to comply with California Health and Safety Code, §116555 and California Code of Regulations, title 22, §64424 and §64430, specifically failure to collect the required number of repeat bacteriological samples and triggered source sample within the required timeframe.
