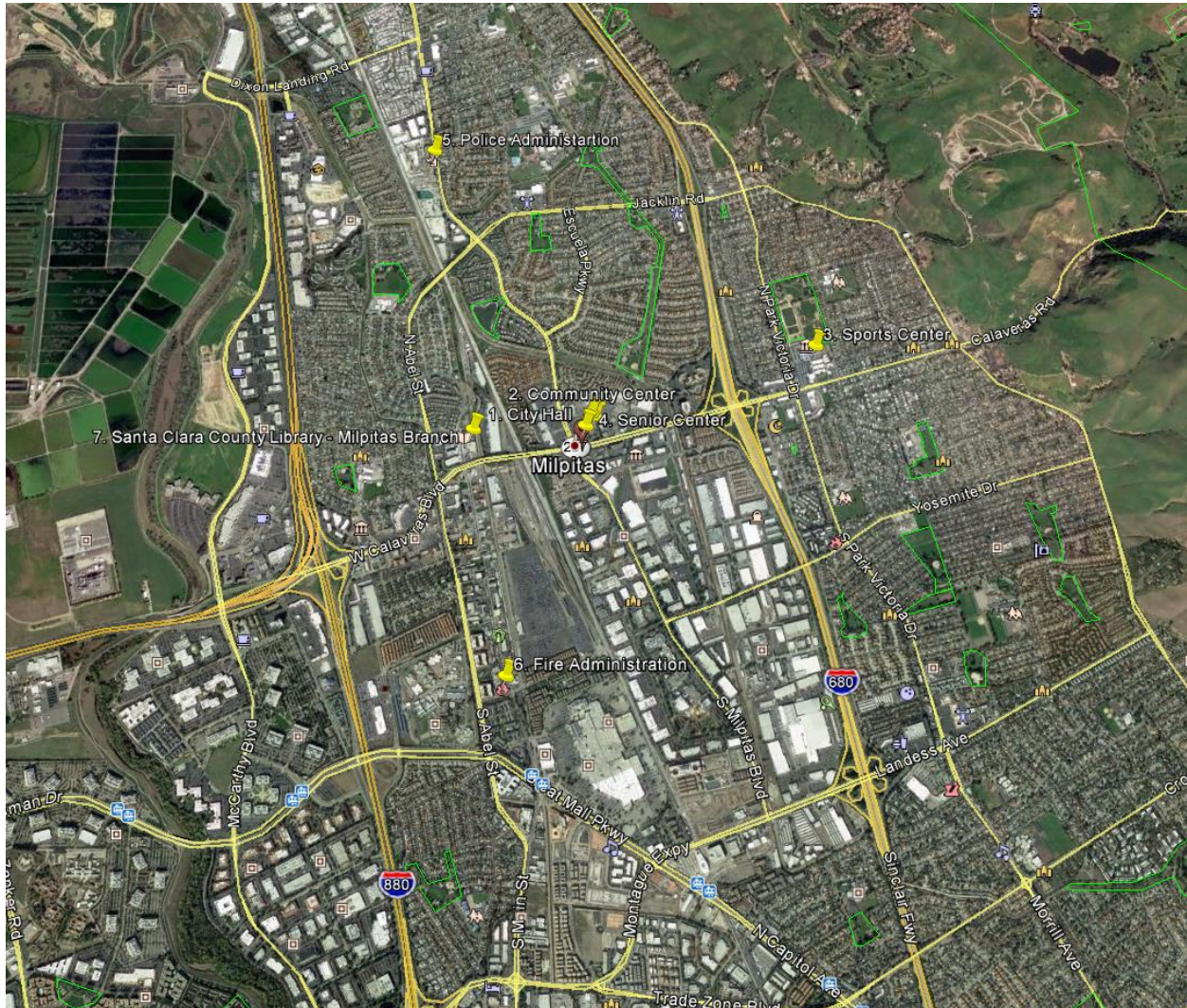
2022 Consumer Confidence Report Notice

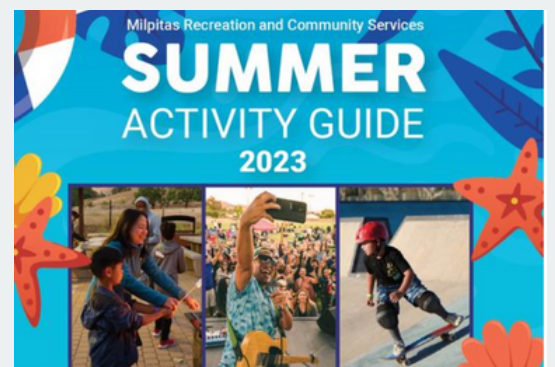
MILPITAS PLANNING DIRECTOR NED THOMAS APPOINTED ACTING CITY MANAGER

This action took effect Monday June 26, 2023, and will continue on an interim or temporary basis until Council takes subsequent action. Thomas has served as Planning Director for the City of Milpitas since August 2018. In this capacity, he has directed work on a broad range of matters related to land use planning, zoning code enforcement, urban design, economic development, and environmental review. Recent work includes updates to the Milpitas General Plan and Transit Area Specific Plan as well as ongoing updates to the Midtown Specific Plan and Zoning Ordinance. Thomas brings more than twenty-five years of experience in local government and public administration to the role of Acting City Manager.

MILPITAS CITY COUNCIL UNANIMOUSLY APPROVES AMERICAN RESCUE PLAN ACT DEVELOPMENT GRANT

On Wednesday, June 8, 2023, the Milpitas City Council unanimously approved an American Rescue Plan Act (ARPA) Workforce Development grant of \$30,000 to launch the Milpitas Adult Education (MAE) Career Training Center, which will ignite new workforce development opportunities for Milpitas residents. The Milpitas Unified School District's adult education program provides academic classes for English Language Learners, high school credit recovery, GED, high school diploma, and other services to secondary school and adult students. The addition of the Career Training Center will be a key component of the programs and services to be offered at the new MUSD Innovation Campus. Phase I of the MUSD Innovation Campus will open Fall 2023.

METROPOLITAN TRANSPORTATION COMMISSION AWARDS MILPITAS \$800,000 GRANT

On June 28, 2023, the Metropolitan Transportation Commission (MTC), the regional planning agency for the Bay Area, awarded the City of Milpitas a total of \$800,000 in grant funding through its Priority Development Area (PDA) Planning Grant Program. This program provides funding for local projects that implement Plan Bay Area 2050, which is a 30-year regional plan that charts a course for a Bay Area that is affordable, connected, diverse, and healthy for all residents through 2050 and beyond. The City received \$600,000 to prepare the Milpitas Main Street Sense of Place Plan and the remaining \$200,000 will be used to prepare the Milpitas Innovation District Parks and Trails Master Plan.



MILPITAS PHILIPPINE INDEPENDENCE DAY FLAG RAISING EVENT

On June 24, the City of Milpitas commemorated the very first flag raising ceremony in the Philippines, 125 years ago. A flag raising event was held at the Cesar Chavez Plaza, led by the Milpitas City Council and members of the Filipino American Chamber of Commerce of Silicon Valley. The occasion was attended by members of the Milpitas community, Fremont Mayor Lily Mei, District Director Anurag Pal from Assemblymember Alex Lee's Office, Filipino Community Leader Ben Menor, members of Milpitas Commissions, other special guests and City staff. The event was capped with several folk dance performances showcasing the rich culture and heritage of the Philippines.

DEVELOPMENT PROJECT CONSTRUCTION UPDATE

Sango Court Apartments, 355 Sango Ct., (2) four-story residential buildings of wood modular construction above first floor concrete podiums with a steel bridge connecting the two buildings providing 102 affordable housing units by Resources for Community Development.

Site improvement work including benches, planters, sidewalk and driveway are progressing well. Permanent power inspection was passed by PG&E. Temporary “manlift” elevator has been removed from the exterior when the permanent elevator was inspected and finalized by the State. See below photo.
