# Pine Grove Mobilehome Park Has Levels of Manganese Above the Secondary Maximum Contaminant Level and the U.S. EPA Lifetime Health Advisory

Our water system recently violated the Secondary Maximum Contaminant Level (MCL). A secondary standard affects the color and taste of the water delivered to customers, As our customers, you have a right to know what you should do, what happened, and what we are doing to correct this situation.

We routinely monitor for the presence of drinking water contaminants. This well has been tested 25 times for manganese since it 2012; results ranged from 350 to 506 ppb. Samples sample collected in December 2016 had manganese measured at 506 ppb and the samples collected November 2021 had manganese measured at 433 ppb. This is above the secondary MCL of 0.05 milligrams per liter (mg/L) and above the U.S. EPA lifetime health advisory (HA) level of 0.3 mg/L.

#### What should I do?

- Infants younger than 6 months could experience neurological effects from continuous manganese exposures above 0.3 mg/L. The State Water Board strongly recommends the use of an alternate water source when preparing food, specifically baby formula and juice, for infants.
- For all other consumers, you do not need to use an alternative water supply (e.g., bottled water).
- This is not an emergency. If it had been, you would have been notified immediately. However, some people who drink water containing manganese in excess of the U.S. EPA lifetime HA level (0.3 mg/L) over many years may experience potential neurological effects.
- If you have other health issues concerning the consumption of this water, you may wish to consult your doctor.

#### What happened? What is being done?

We are testing the drinking water source quarterly. We will be working with a certified water treatment engineer to come up with a filtration and/or treatment system, which can be approved by Shasta County Environmental Health, to remove the manganese out of the drinking water. We are also working towards consolidating with the Fall River Valley Community Service District (CSD).

#### **Secondary Notification Requirements**

Should the water sample results exceed the U.S. EPA HA of 0.3 mg/L [Health and Safety Code Section 116450(e)].

Upon receipt of notification from a person operating a public water system, the following notification must be given within 10 days [Health and Safety Code Section 116450(g)]:

- SCHOOLS: Must notify school employees, students, and parents (if the students are minors).
- RESIDENTIAL RENTAL PROPERTY OWNERS OR MANAGERS (including nursing homes and care facilities): Must notify tenants.
- BUSINESS PROPERTY OWNERS, MANAGERS, OR OPERATORS: Must notify employees of businesses located on the property.
