### **What you should know:**

Your water is tested every month for the presence of bacteria. Both the raw and finished water are tested for a total of 24 bacteria tests per year.

**All of the tests in 2020 came back clean.**

“Raw Water” is the water that comes out of the ground before it enters the water system.

“Finished Water” is essentially the same as the raw water except that it contains a trace of chlorine.

In addition to the 24 bacteria tests conducted in 2020, the district conducted 14 other less frequently required water tests, all with good results. The fourteen tests were: Copper at five residences and Lead at five residences (10 tests) plus one test each for Nitrate, Odor, Color and Turbidity.

The State Division of Drinking Water requires that we conduct tests for approx. 69 different things. The required frequency for each test varies. To see the complete schedule with results please visit our website:
