Our consumers are the students and staff of a school and school district office. We used our communications platform ParentSquare to attach a pdf of the CCR in a message to families and staff. The message included sending an email with the CCR attached, a text with a link to the ParentSquare message with the attachment, and an app notification that linked to the same message and attachment. We have communication with 100% of our families and staff using at least one of those methods based on their notification preferences. If unable to open the attachment, they can reach out to the district office through ParentSquare or by coming into our office which is open to the public weekdays, except holidays.
