Drinking Water Source Assessment Information: Well 01 meets all primary and secondary chemical drinking water standards, with the exception of the secondary standards for manganese and odor. Well 03 & Well 04 meet all primary and secondary chemical drinking water standards except for the secondary standards for manganese, iron, and turbidity. It is very likely that due to the shallowness of the wells and natural occurrences such as a large amount of gravel noted in the Well driller's log. All wells are under the influence of surface water during certain times of the year, if not year-round, and have been developed to avoid extreme influences. The wells are considered vulnerable to activities within 2400 feet of the wellheads.

Sources of Drinking Water and Contaminants that May Be Present in Source Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, that can be naturally occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides that may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, are byproducts of industrial processes and petroleum production and can also come from gas stations, urban stormwater runoff, agricultural applications, and septic systems.
- Radioactive contaminants that can be naturally occurring or be the result of oil and gas production and mining activities.

Regulation of Drinking Water and Bottled Water Quality

In order to ensure that tap water is safe to drink, the U.S. EPA and the State Board prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. The U.S. Food and Drug Administration regulations and California law also establish limits for contaminants in bottled water that provide the same protection for public health.
