## Sources of Drinking Water and Contaminants that May Be Present in Source Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, that can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, that may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, that are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, agricultural application, and septic systems.
- Radioactive contaminants, that can be naturally-occurring or be the result of oil and gas production and mining activities.

## Regulation of Drinking Water and Bottled Water Quality

In order to ensure that tap water is safe to drink, the U.S. EPA and the State Board prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. The U.S. Food and Drug Administration regulations and California law also establish limits for contaminants in bottled water that provide the same protection for public health.

#### Failure to Provide a Reliable and Adequate Supply of Water for 2021-2023

Speedway Sonoma, as a public water system, is required to provide a reliable and adequate supply of pure, wholesome, healthful, and potable water. A public water system is required to have water sources with the capacity to meet maximum day demand at all times. Maximum day demand represents the measured or estimated amount of potable water used during the highest water demand in a 10-year period. If a public water system cannot supply the maximum day demand, then is does not have adequate source capacity. It was determined by the State Water Board that Speedway Sonoma has violated this requirement in 2021, 2022, 2023, and 2024.

Speedway Sonoma relied extensively on hauled water in 2021, 2022, 2023, and 2024 due to the sustained reduced capacity from its spring and well sources. Speedway Sonoma's inadequate source of supply and the consequent need to use hauled water may result in water outages and low pressures, which present a health hazard due to potential intrusion of contaminants.

Speedway Sonoma is working the State Water Board to meet maximum day demand requirements and bring the facility back to compliance.
