

The City of Ceres Public Works Department placed a newspaper ad in the Ceres Courier on June 12, 2024 informing residents on the availability of the Consumer Confidence Report for 2023. The posting of the CCR was on June 28, 2024, on the website and a newsflash was sent out directing the public to the CCR. A social media post informing residents of upcoming availability was posted 6/18/24. The department sent out electronic delivery on June 29, 2024, CCR to 3,357 BillPay and paperless customers. The availability has the link to the report with our phone number and address for those who would like to request a physical copy.
