Each year, the City of Woodland prepares a Consumer Confident Report (CCR), also known as an Annual Water Quality Report, which summarized the results of all the testing detected in drinking water during the year prior. The Safe Drinking Water Act (SDWA) requires the city to make this report available and accessible to City of Woodland water supply users. The purpose of the CCR is to raise customer awareness of the quality of their drinking water, where their drinking water comes from, what it takes to deliver water to their homes, and the importance of protecting drinking water sources.

In the past, City of Woodland has mailed its customers a printed copy of the CCR to comply with the SDWA. In 2013, the State of California expanded its interpretation of the SDWA to allow for electronic delivery of the CCR. The electronic delivery method allows City of Woodland to reduce the consumption of paper, and minimize potential printing and mailing costs.
